

1. I, Sudeshkumar V. Joshi, Proprietor of M/s. Sudeshkumar & Associates, Chartered Accountants (Membership No. 043678), Mumbai, have been appointed by the Board of Directors of **Hotel Rugby Limited** (the Company) as the Scrutinizer for the purpose of scrutinizing remote e-Voting Process along with e-voting at the AGM in a fair and transparent manner and ascertaining the requisite majority on Voting carried out as per the provisions of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 in respect of the Resolutions passed at the 30th Annual General Meeting (AGM) of the Members of the Company, held on Wednesday, the 29th day of September, 2021.

3. Further to the above, I submit my Report as under:-


- i. The Remote e-Voting period remained open from Saturday, 25th September, 2021 (9.00 A.M.) to Tuesday, 28th September, 2021 (5.00 P.M.)
- ii. The Members of the Company as on the "cut-off" date i.e. 22nd September, 2021 were entitled to vote on the Resolutions (Items No. 1 to 4 as set out in the Notice of the 30th AGM of the Company).
- iii. The votes cast via remote e-voting were blocked on Tuesday, 28th August, 2021 immediately after completion of voting hours.
- iv. The facility for e-voting at the AGM was provided at the 30th AGM on Wednesday, the 29th day of September, 2021 for those members who attended the meeting but had not voted through the remote e-voting facility. Thereafter, the electronic votes cast through remote e-voting were unblocked at 11:32 a.m. i.e. after counting the votes cast through e-voting at the AGM in the presence of 2 witnesses Mr. Ajay V. Mehta, Practicing Company Secretary (ACS - 9332) and Mr. Nayan Shah (ACS - 63291) who are not in the employment of the Company.
- v. Then, the details containing, inter alia, list of Equity Shareholders, who voted through Remote e-voting and by e-voting at the AGM, "for" and/or "against" each of the resolutions that were put to vote, were generated from the e-Voting website of LIIPL i.e. <https://instavote.linkintime.co.in>
- vi. The Register to record the assent or dissent received has been maintained electronically. It contained the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them, nominal value of such shares. There were no shares with differential voting rights in the Company; hence there is no requirement of maintaining the list of shares with differential voting rights.
