

- I. The name of the Company is "UNIVA FOODS LIMITED" (1)
- II. The registered Office of the Company will be situated in the State of Telangana (2).
- III. The Objects for which the Company is established are:

(A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUANT BY THE COMPANY ON ITS INCORPORATION:

- To enter into Partnership in and/or to take over acquire or to take over acquire or purchase as a going concern, the assets and liabilities of the Univa Foods engaged in the business of running a hotel as such take-over of the firm shall stand dissolved after the agreement.
- To carry on the business of Hotelier, Restaurant or to provide lodging and boarding, eating houses, bar swimming pool and other facilities to the Public including tourists, visitors and other delegate coming to India from foreign countries and to members of delegations and missions from foreign countries.
- To own, construct, run, render technical advice in constructing, furnishing and running of, take over, manage, carry on the business of hotel, restaurant, cafe, tavern, bars, refreshment-rooms, boarding and lodging, house keepers, clubs in India or any other part of the world.

(B) THE OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS:-

- 4. To carry on the business of buy, sell, export, import, give take on lease, give or take on hire purchase or on deferred credit and or on license service and repairs of or otherwise deal in any manner the Plant & Machinery, Furniture & Fixtures, Air conditioner & Refrigerator required by Hotel industry and also deal in spares and stores of all such items mention above.
- 5. To buy, sale, Construct, Hotels and Restaurants, motels, Resorts, and do deal in land for the above purpose veries, tools as referred to above from any person, Government, Central or State or, any Government department or undertaking.
- 6. To adopt such means of making known the products of the Company as may seem expedient and in particular by advertising in the press, by circulars, by purchase and exhibition, by works of Interest, by publication of books, periodicals and by granting prizes, rewards and donations.
- 7. To acquire and take over business or undertaking carried on in connection with any land or building which the Company may desire to acquire or become interested .in and the whole or any of the assets and liabilities of such business or undertaking and to carry on the same or to dispose off or remove or put an end thereto or otherwise deal with the same as may seem expedient.
- 8. To collaborate with foreign. firms for acquiring or offering technical know- how, or to employ foreign technicians or experts or advisers on a contract basis or otherwise and to loan on suitable term Company's technicians, experts and others to other parties in or outside India for developing hotel industries and to send out to foreign countries the Company's own technicians, in foreign countries on a joint venture basis or otherwise and to send out Company's men to foreign countries for further training.
- 9. To provide technical know-how and management services to parties in India or elsewhere for the running of hotels.
- 10. or profit of the Company and to hold shares or Interest in any such company or partner.

- 11. To enter into partnership or into any arrangement for sharing profits, union of interest' co-operation, joint venture, reciprocal concession or otherwise with any person or company carrying on or engaged in or about to carry on. or otherwise assist any such person or company and to take or otherwise acquire shares and Securities of any such company and to hold, sell or otherwise deal With the same.
- 12. The form or let out the traffic or business of the Company or any part thereof or to sell or transfer the same or any part thereof, permanently or temporarily to any other company or compile or person as may be thought desirable on any term and conditions which may be thought proper.
- 13. To enter into any contract or arrangement with any Government or Authority, supreme municipal, local or otherwise that may seem conducive to the Companies. Object or any of them and to obtain from any such Government or authority any rights, privileges and concession.
- 14. - 18. To purchase or otherwise acquire and undertake the whole or any part of the business, property, rights and liabilities of any person, from or companies, carrying on any business which this Company is authorized to carry on, to purchase, acquire and sell property, shares, debentures of any such person, firm or company and to conduct, make or carry into effect any arrangement in regard to the winding-up of the business of any such persons, firm or company.
- 19. To promote and form and to be interested in and take hold of and dispose of shares in other companies for all or any of the object mentioned in this Memorandum and to subsidies or otherwise assist any such company.
- 20. To pay out of the funds of the Company expenses of and incidental to the promotion, formation, organization, registrations, advertisement and establishments of the Company end the issue and subscription of shares or loan capital including brokerage and/or commission is respect thereof and also all expenses attending the issue or any circular or notice and the printing, stamping, circulation of proxies and forms to be filled up by the member of the Company.
- 21. Subject to the provisions of the Companies Act 1956, to place to reserve or to distribute as bonus, Shares, among the members or otherwise to apply as the Company, may from time to time think fit, any moneys received by way of premium on shares or debentures issued at premium by the Company.
- 22. To insure against loss of money, principal and interest lend, invested or secured as mortgage, debenture deposits and loans of every kind and to banking, property, Investment or financial companies.
- 23. towards insurance and to support, subscribe contribute to or otherwise assist any charitable, benevolent, religious Scientific, national or any other Institutions, associations, Organizations, objects or purposes or for any exhibition and without prejudice to the generality of the foregoing provision and in furtherance thereof the Directors may give such aid, support or assistance to such individuals and bodies (incorporated or un-incorporated) including in particular:

- I. Granting of Loans without or at interest and without or with such security and repayable in installment, and
- II. Grant or contribution towards maintenance of and support to any individual or body.
- 25. To provide for the welfare of any employee or employees (past or present) of the Company their wives, widows and families or the dependent or connections of such person by grants of money pension, allowances, bonus or other payment or by creating and from time to time subscribing to provide institutions or associations, funds or trusts and by providing or subscribing to or contributing toward place of instruction and recreation, hospitals and dispensaries, medical' and other attendance and other assistance as the Company shall think fit and otherwise to assist or aid by the company either by reason of locality of operation of utility to the Company or its employees.

- buildings, or part of building, interest in and any right over or connected with any such lands, buildings structures.
- 30. To pay for any properties, rights or privileges acquired by this company either in shares of this company or partly in shares and partly in cash or otherwise and to give shares of the Company in exchange for shares of any others company.
- 31. To sell, Issue, mortgage, surrender, abandon and in any other manner deal with or dispose of the undertaking or property of the company or any part thereof for such consideration or as the company may think fit and in any other company having objects altogether or in particular for shares, debentures and other securities of similar to those of the Company.
- 32. To Subscribe to or otherwise aid benevolent, charitable or other institutions or objects of a public character or which have any moral or other claim or support on aid by the Company by reason the locality of its operations Otherwise.
